No indications for teratogenic effects were found in the teratology phase of the 2-generation reproduction study in rats and in a tolerance study with pigs receiving 20 mg altrenogest/day on days 28 to 112 of pregnancy.

16. OTHER INFORMATION

Additional information **WORKPLACE CONTROLS AND PRACTICES:** Unless a less toxic chemical can be substituted for a hazardous substance, **ENGINEERING CONTROLS** are the most effective way of reducing exposure.
