**Carcinogenicity** Not classified as a carcinogen.

Reproductive Contains ingredients that have had some effect on reproductive performance in animal studies. Miconazole

has not shown teratogenic effects but is embryotoxic following high oral doses. Studies in mice, rabbits, hamsters and rats showed that prednisolone caused malformations including cleft palate when administered

parenterally. The teratogenic potential was much less when prednisolone was administered orally.

#### Additional information

WORKPLACE CONTROLS AND PRACTICES: Unless a less toxic chemical can be substituted for a hazardous substance, ENGINEERING CONTROLS are the most effective way of reducing exposure. The best protection is to enclose operations and/or provide local exhaust ventilation at the site of chemical release. Isolating operations can also reduce exposure.
