Uses advised against Do not use for the treatment of deep pyoderma. Do not use in pyotraumatic furunculosis and pyotraumatic folliculitis with 'satellite' lesions of papules or pustules. Do not use where fungal or viral infection is present. Do not apply to the eye. Do not use over large surface areas or for prolonged treatment. Do not use in cases of known hypersensitivity to the active substances or to any of the excipients.

Eye	If in eyes, hold eyelids apart and flush continuously with running water. Continue flushing until advised to stop by a Poisons Information Centre, a doctor, or for at least 15 minutes.
