Specific treatment:

Treatment for any adverse effects should be symptomatic. Cephalixin is widely distributed in body fluids and tissues including pleural, pericardial, peritoneal and synovial fluid. It also crosses the placenta. The blood brain barrier is only significantly crossed in the presence of inflammation.

Notes for the doctor:

Treat symptomatically.
